- **Excursions:** I/We give permission for our child to take part in regular trips in the local community with a minimum teacher: child ratio of 1:4. I/We agree that our child can take part in planned activities in the car park area/vegetable garden at Pebbles with a minimum teacher; child ratio of 1:6 and 2:18. All other planned excursions will require parental consent.
- **Photo/video:** I/We give permission for our child to be photographed for the purposes of assessment, planning and evaluation. These photos may appear on our website and may be used for advertising purposes.

Other information

- **Policy Statement:** Pebbles Montessori has a number of policies that set out the procedures that are in place for the care and education of the children who attend. We strongly urge you to read these. The signing of this enrolment agreement form indicates that you will abide by the policies of this service, and understand how you can have input to policy review.
- **Fee Schedule:** I have read and agree to the fee schedule and agree to enrol my child for a minimum of TWO sessions per week.
- **Holidays:** I am aware that fees are still payable when my child is absent. I am entitled to up to 2 weeks absences per year at 50% discount with prior notice. Pebbles Montessori does not charge for public holidays.
- **Child Leaving Pebbles Montessori:** I understand that two weeks notice needs to be given before withdrawing my child from the centre.
- **Photos:** As part of the planning process we gather art work and photos of all children, I agree that my child may have their photo taken by employed staff and students in training for assessment purposes. These photos may also be uploaded to your child's Educa profile on line. Photos may be included in other children's learning journals where applicable.
- **Advertising Material:** I understand photos may possibly be used for Pebbles Montessori promotional material such as Centre newsletters, website and local newspapers.
- **Medical Treatment:** I give permission for my child to be given basic first aid treatment by the centre teachers and my child to be taken to an alternative location in an emergency (e.g. Civil Defence Sector). I agree to my child being taken by an ambulance in an emergency situation and I accept responsibility for any expenses incurred in obtaining treatment for my child.
I understand that the centre cannot accept my child when they are sick.
